AMENDMENT TO THE DECLARATION OF TOBEY WOODS CONDOMINIUM

This Amendment is executed and delivered by Tobey Woods Condominium, a New York condominium formed under Article 9-B of the NYS Real Property Law, acting through its Board of Managers, with an address at 2 Tobey Woods, Pittsford, New York 14534.

WHEREAS, the Declaration of the Tobey Woods Condominium was originally filed in the Monroe County Clerk's Office on November 1, 1974 in Liber 04749 of Deeds, page 84, and further modified to amend and restate the By-Laws which were attached thereto, by the filing of the Amended and Restated By-Laws in the Monroe County Clerk's Office on November 12, 2013 at Liber 11326 of Deeds, page 317 (the "Declaration");

WHEREAS, Article XI of the Declaration provides each unit owner shall be liable for a proportionate share of the common expenses in accordance with their respective common interests; and

WHEREAS, the Board of Managers proposed to change the method of allocation of the common expenses from a proportion based on the unit owner's common interest, to an equal allocation regardless of common interest owned; and

WHEREAS, the unit owners unanimously approved and adopted the modification and change.

NOW THEREFORE, pursuant to Article XIII—Amendments, the Declaration is amended as follows:

In compliance with NYS RPL 339i, Paragraph 5—Percentage of Interest in Common Elements, is restated to provide each unit owner shall have an equal undivided interest in the common elements.

In compliance with NYS RPL 339m, Article I, Section A., and Article XI, Section A., are revised to provide that each unit owner shall be liable for an equal share of common expenses, that is $1/32^{nd}$ for each unit, and any common surplus shall be owned by each unit owner in like share.

Except as otherwise amended, the Declaration of the Tobey Woods Condominium is hereby affirmed and in full force and effect.
