Review for Approval - BOD meeting Minutes of August 22,2024 were motioned for approval by Patti and seconded by Bob. All approved

President's Message – Paul paid tribute to Mike Goodman for all of his contributions to our community, especially as Pool director. Paul also mentioned to be aware of scams community members have been receiving.

Report from our Property Manager - Jim Manetta -

- Manel Sealers has scheduled crack filling and sealing of the designated driveways for Monday, September 16th and Tuesday, September 17th (weather permitting)
- Porretta has scheduled repair of the catch basin in the front circle for Wednesday, September 11th. That date is fluid as Mark has another big job he's finishing up first, and if there is any delay with that job, this one may be pushed back a bit. However, his work will not disrupt traffic as the rest of the circle will be open.
- A 9-month CD was purchased for \$208,000 @ 4.4%. Maturity date is 6/4/25
- The information related to snow birds was shared with Waste Management and they will consider a discount for the months that service addresses are reduced.

- Paul and I met with Bevin of Pittsford Tree & Landscape to discuss shrub and arb removal / replacements. She will submit a proposal for that work, with a target of October for the work to be done.
- All HOA fees are paid up-to-date except one \$33 June late fee.

- Manetta will be out of town from Monday, September 9th thru Tuesday, September 24th. Jacquie and the rest of our staff will be available for urgent matters.

Financial / Treasurer's Report – Paul Keitz

1. Treasurer Executive Summary - For August 2024

- Our HOA has a total of \$65,948.97 available in our Operating Fund as of the end of August. Total operating fund Income for August was \$38,578.50 and paid expenses were \$37,916.82.
- Our HOA has a total Maintenance Reserve Account of \$738,015.85 allocated for long term repair/replacement for identified reserve assets. We currently have \$670,000 in CD's and \$68,015.85 in cash reserve savings. \$34,325.00 was transferred from the cash reserve account to pay for the necessary road repairs.
- Our HOA has a Total net worth of \$803,964.82 as of closing on 08/31/24.

- The carpet will need to be cleaned after painting.
