Parking when Renting our Clubhouse

It seems there may be confusion regarding guest parking when a resident hosts an event in the clubhouse. To enable resident hosts to plan parking needs and inform their guests in advance of the event, we offer the following:

There are a total of 26 parking spaces available for guests:

- 14 spaces at the clubhouse,
- 4 spaces in the overflow lot between units #92 and #100, and
- 8 spaces in the overflow lot across from units #53 and #57.

In view of the above, if you are hosting more than 26 guests, we ask resident hosts to:

- suggest that guests carpool wherever possible.
- suggest that guests be dropped off at the clubhouse before the driver parks in one of our overflow lots; and
- perhaps ask neighbors if it might be possible to access some of their parking space during a clubhouse event.

We recognize the challenge for all concerned, encourage cooperation to the greatest extent possible, and trust that the above information will be helpful in planning a successful event.

IMPORTANT:

Per the Town of Greece Fire Marshal, no parking on Maple Center Road is permitted at any time to provide full access to emergency vehicles.
